### **Purpose of the meeting**

The 24<sup>th</sup> meeting of a Working Group 5 on Road Traffic Safety is a part of the CSS II project in Kharkiv Region. The purpose was to discuss:

1. KHADI course on Audit of RTS postponed until after the quarantine due to COVID-19 situation;
2. UKRAVTODOR interactive maps and problems in legislation and internal SOPs that prevent the efficient exchange of information between NPU and UKRAVTODOR on road traffic accidents (RTAs);
3. Road Traffic Safety week campaign – activities that can be implemented by working group online.
4. Livi Velicea's presentation about the report on drunken driving laws in UA

### **Content (key points for the next meeting)**

- 1) **Livi Velicea will give an overview of the report on the drunk driving for the next meeting.** Livi Velicea's presentation about the report on the drunk driving and some law proposals made by EUAM HQ was postponed to the next meeting.

- 2) **The UkrAvtodor interactive map of Ukraine`s Roads:** WG did not receive any feedback from HQ about UKRAvtodor interactive map yet. This question will be discussed more in the next meeting after having the needed feedback.
- 3) **The KHADI course on Audit of RTS for police officers in Kharkiv Region dealing with RTAs:** WG did not receive any feedback from Yevhenii Petrov about the draft curriculum, but it was agreed not to wait more but to send curriculum to EUAM HQ. WG will proceed on KHADI course by trying to do all the paperwork so that when the course can take place it can be done immediately.
- 4) **RTS week in May 2020:** WG had a discussion about communication plan for Road Traffic Safety week starting 18.5. Patrol Police is having a lot of ideas, they will do a lot of social media activities and also etc. paint some streets signs. The Roads Service Office of UkrAvtodor in Kharkiv Region promised to provide paint for painting the signs. Patrol Police are planning to have 10 minutes long live-streams with their inspectors from different units every day. They want to find a good painter who could paint the RTS rules and who could do it for free, since they don't have funds for this. They are also planning to make short videos on using cellphones when driving, seatbelts; the RTS unit will find some videos with main reasons for RTAs. UkrAvtodor is planning to inspect the quality of roads during the RTS week, they are waiting for official information from their MHQ when this week will take place.
